Hike H. said Pam will look into clarifying the definition of use for Park Dedication funds if it can only be spent on new parks or can it be used for enhancement of existing parks.

David J. brought up obtaining high visibility vests for when volunteers are doing events. Mike P. motion for high visibility vests, David J. second, approved for an order of 12 vests. David will check with Pam to verify no sales tax. David will verify with LSF their order of the same vests. Mike P. also wanted "Volunteer" added to the back of the vests.

Discussion held on the Linwood School Forest as it operates on its own and covers its own expenses.

Weather was really warm so the attendance was very low at the Linwood Winter Fun Day. Hockey rink is currently closed until weather permits.

Confusion on where the cow-pies are to be stored for LFFD. They were put into the warming shed. We prefer they will be moved to a different location such as outside under a tarp or in the salt shed. Kris made a motion to move cow-pies, second by Melvin, motion passed. Kris will send an email to Chris Lecy to notify of our request.

Gary may check in to a fishing pier on Martin Lake. Gary noted there were some spelling errors on the website, will inform Carol Searing.

Kris noted a friend used the exercise equipment at Boettcher Park and hurt a muscle while on it. Discussion on whether to put "Use at your own risk", we noted it was user error.

Gary has noted that four "Park Arrow" signs are up, he requests vinyl or rubber washers to be used so the vinyl doesn't tear upon installation. Gary and Mike H. will bring to attention of maintenance department.

Gary brought in an aluminum interpretive sign that Anoka Ramsey had made for the parks. We will have them installed in the existing locations. We are planning on doing a working meeting and install the 11 signs that were made. Will do for either September or October meeting. We will need to purchase some additional posts. Gary will check on hardware needs.

We will plan to update the DNR once the sign is updated on the windswept prairie.

Gary brought up whether to landscape below park signs and the maintenance required. Question whether to flatten the landscaping mounds and just have grass as the landscaping and shrubs are not properly maintained and does not look nice. Conclusion is to have more working meetings to improve the signs and remove the landscaping and turn to grass. Starting park would be Martin Lake shores since we need to do some trimming of trees there. Tentative date of October 26th meeting to work at Martin Lake Shores and September 28th signs in the forest/parks.

Melvin brought in tag of fence requested for protecting trees, request of 2 rolls 72 inch, 14 gauge 50 feet. Also 25 treated landscape timbers. Melvin and David fenced in trees in Broadbent park, Melvin has sprayed for weeds around base this summer to upkeep the look of the fenced trees.

We need to send a letter to past residents that signed up to adopt a park. Request if they would like to continue their adoption. Will ask Mike Pederson if he has that information.

Melvin has been maintaining the garden in 4-seasons park, would like to build a fence to protect the garden, Mike H. mentioned that let's move forward with these projects. Melvin will assess hardware needs.

Bob Millerbernd brought up items such as check list of items to be done seasonally, for example take tennis nets down before winter. We as a Park board will create a standing list to assist maintenance with seasonal needs. To be addressed at the next meeting. Start with

your assigned park and bring list to next meeting.

Bob also questioned whether the basketball court in Broadbent Park should be refinished. The Park board will start compiling a list for the maintenance department to assist with their maintenance. We will add to the agenda as a standing item and add to the list and submit quarterly to maintenance department. Melvin stressed to account for additional expenses so they are counted in the budget for future.

Gary will request a Park Volunteer vest from Mike Pederson for working in the parks.

Also we would like to improve and increase the parking lot on the North side of the Linwood School Forest. Tabled for future discussion.

Mike addressed the conversation that we had regarding the fishing pier on Martin Lake we had discussed at our last meeting and our maintenance issues with the parks such as Martin Lake Shores park.

Public input on the subject from those in attendance: Prefer it to be by boat launch for access and parking. People swim at the beach, would that take away from swimming access? Could anchor the tables to the ground so they are not continuously moved into the water. Liability from a township perspective? There are right-of-ways to Martin and Linwood Lakes. It could hurt the fish population. Would we consider having a working day on a weekend? Bob Millerbernd noted he had consulted with the conservation department and they stated the trees around the pond in Martin Lake Park should be removed to improve the system and someone from Anoka County will be at our working meeting as well to assist.

Gary noted that unless the DNR approves the site, it wouldn't be an option. The DNR only approves about 3 or 4 per year and generally are approved with cost sharing from local governments. Mike H. asked if they need to be handicapped accessible, Gary wasn't sure. Melvin noted that he had read the Forest Lake paper that Martin Lake had a very high fish kill due to over population, a member in the meeting said it could have been due to a parasite. David brought up the idea of grooming it more for swimming and the general consensus was those in attendance were in favor of that over a fishing pier. Mike H. also mentioned the holding pond was created to allow for the run-off to flow there first before it gets to the lake. Caution should be used to kill weeds and tree stumps around the lake. Mike P. noted to continue this discussion as we progress, but to start with the clean-up first and make it more presentable as-is.

Gary made a motion to adopt the minutes, second by Melvin, approved.

Melvin brought up the parking lot on the North side of the LSF with Ed Kramer and improving the lot and expanding it. Mike H. said he had also discussed it with Ed Kramer and they have already began improvements.

Mike P. tabled the adopt a park member list. Mike P. brought up leveling out the hockey rink high spot, Mike H. said that will be addressed. Hockey Rink signs have not yet been posted, Gary said Anoka County was to do that. Plan to try and get up interpretive signs up at wind swept prarie by October.

Seasonal checklist: Add trash receptacle at Martin Lake Park. Move port a potty from Boettcher to Hockey Rink. Take down tennis court nets in fall. At Playful Shadows- remove and store trash bins.

Could we hire a park position to just maintain the parks? Mike H. stated the maintenance department should be able to handle the necessary requests.

Peter Braido has resigned effective as of today for personal reasons as stated in his email. Melvin motion to accept Peter's resignation, David second, motion passed. Mike will draft a letter of acceptance and thanks.

Meeting called to order at 6:03pm

Richard Johnston with Linwood Boy Scout troop updated on Eagle project. He has finished and installed the sign as well as added a wood box over the well pump and leveled the site. Mr. Johnston requested a sign-off on the project and an email to verify our acceptance of the project to richiej@frontier.com. Mike or David will send him an email.

Mike P. asked who owned the generator at Allquist park. It is not in service and rundown. Mike H. mentioned he and Bob Millerbernd will track it down to see if we can get it cleaned up.

Reviewed August minutes-Motion to approve minutes by Kris Millerbernd, second by Melvin, minutes accepted.

Review of working meeting in September at Martin Lake Shores. Mike P, David, Melvin, Gary and Kris were all in attendance as well as approximately 10 residents from the surrounding community. Mike P. stated he had called the maintenance department to ask them spray stumps immediately and was not sure if/when they were treated. It was a week later before brush was picked up. Mike H. stated the stumps were not sprayed. Concern was expressed that if the stumps weren't treated all of the efforts were for nothing. Mike P. expressed frustration that if the necessary follow-through of the maintenance department doesn't happen then our efforts are wasted. Question arose on why the park maintenance has fallen off and what can do to fix it? Kris said we should make a checklist and follow-up on it. Mike H. said he had forwarded the checklist we had provided and he had a meeting with maintenance to try and address some of those issues. Melvin said there needs to be some sort of schedule and direction for these items to be addressed. Mike H. stated there is no head of maintenance. Kris said maybe there should be a work-order submission system to have things addressed especially if items are time- sensitive.

Bob Millerbernd stated it was in a lengthy process with the DNR and road and bridge department to have the pond drudged out at Martin Lake Shores Park. He said the people across the road were very appreciative of the clean-up.

It was noted that we as a board are responsible for overall recommendations to the parks, but we are not responsible to "maintain" the parks.

Mike H. said he will bring up to the board a part-time maintenance person for the summer months to assist with the maintenance and who would be responsible for that additional employee. For example, we have increased the parks like the addition of Boettcher Park, but the maintenance staff has not increased. Mike H said he and Bob M. will bring it up to the township board.

Bob M. asked what was the boards vision for Boettcher park. Orin and Mike P. said there was football played there. Mike H. brought up if we let some of the park go to a natural state or prarie grass because it's not being utilized.

David asked what was the original purpose of the open space at Boettecher. Mike H. said it was to be in partnership with FLAAA to develop baseball and football fields then FLAAA fell through on their end.

Mike H. said Linwood Covenant church was looking for projects to do, they stained the underside of the pavilion at Boettcher. Unfortunately there was a fair amount of stain that dripped onto the concrete.

Melvin said people from the church also helped him plant hundreds of bulbs in 4-seasons park.

Mike P. brought up if we were going to proceed on the dock/fishing pier at Martin Lake Shores. Most were in favor of a dock instead of a pier. It was suggested to table the discussion for future.

Mike P. and Bob said they wanted to know if the hockey rink had the high spot leveled, Mike H. said he will follow up.

Mike P. said we should get a fire and carbon monoxide alarm in the warming shed. Bob M. stated he would like to be able to put a 4x4 on the ground in the open spot to make it easier to flood.

Mike H. said the North side of the LSF parking lot was done for now, but it was expanded and some more maintenance will be required next spring. It looks great.

David said he brought it up at the LSF meeting about a community billboard for that site.

Discussion on the existing parking lot and the LSF board was having signs made to clarify where the new DNR parking lot exists. Melvin noted it has been a lot better with less parking in the LSF lot and more in the new DNR lot.

Next meeting dates November 23rd and December 21st. Mike P and David will inquire about the LSF medallion hunt and if there again will be a winter fun day. Acknowledgement of the new member, Doris Wetjen Meeting adjourned at 7:19pm, motion by Gary, second by Kris passed.

January 30 th is planned for Linwood Winter Fun Day. Last year was 1-4. Question about if there was no availability of ice on the rink, could we move it to Martin Lake? Discussion included ice rink flooding and how last year looked in comparison to this year. What would parking look like at Martin Lake Shores if we held the event there? DNR lot would work. Another alternative would be Linwood Lake. If the weather is not cold enough by the first week of January ,we can't flood and will have to make different arrangements. If we did the event on the lake, we could hold a fishing tournament but would need to have at least 15 inches of ice. Mike H will call attorney to find out about liability of holding the event on the ice. Gary will check with DNR to see if there are any restrictions or permits needed if we want to hold a fishing contest . Promotion of event was done through school. Emily R will coordinate with Mike P to distribute flyer. Want this event to coordinate with School Forest medallion hunt and possible moonlight hike. PARC could help with moonlight hike with possible bonfire, etc. Moonlight hike will be held same day, approximately 5-6pm. Turnout for skating party last year was lowest due to warm weather.

History of cell tower relationship/agreement with DNR land we received a grant for years ago. As a result of the cell tower being installed, the township may not be eligible for further DNR grants. Township attorney is looking into the agreement and ramifications.

Boettcher Park discussion about what we should be doing with it. David had a discussion with a neighbor, regarding letting the area go, put in walking path, natural vegetation, or trees. DO we have a plan for this park use? Melvin suggested community garden. Mike H expressed this is a great idea. Discussion about the need for fencing, water sprinklers. Mike H can ask to put it on the website to get feedback from residents and will include in the quarterly newsletter. Melvin suggested possibly putting an orchard in that area. Closer to spring, we will ask public for additional feedback.

Tamarak Lake: do we have a vision for this area of land? Same with Paradise Park.? In spring we should promote Paradise Point as a canoe launch area, possibly make a sign for the area. There is a bench there but no picnic table. Maybe put railroad ties or wooden ramp to help launch watercraft. On tour, we will evaluate accessibility and look at options for further development. Tamarak is mostly swamp area and not valuable for development. On spring tour, look at Northstar Park on Typo lake.

Windswept prairie signs have all been remade by Anoka County Community College . Gary is holding the signs right now. David will contact Gary during holiday break to put some signs up. David will send an email to PARC when ready to put up signs and those available, can help post those signs. David will bring School Forest signs also to put them up.

Next meeting will be held January 25th at 6pm. Motion to adjourn by Melvin, Gary second the motion. Meeting adjourned at 7:00pm.

- Discussion continued on the land swap inquiry, Brigit stated she recently spoke with Mr. Jungbauer and he noted that a land swap was not an option. Mike H. concurred from what he understood about the matter that it was not an option either.
- Gary brought up the idea of a concrete corn hole structure to consider in the parks. Something to consider.
- Mike P. brought up the rink liner, found a company in Sauk Center, 120x200 for \$1440. Reinforced ripstock for \$2,300. Mike H and Bob Millerbernd brought up how to store it in the office. Kris brought up concern of it getting cut by skates or damaged in storage. David asked if it was still being considered to split the rink in half, Mike P. said it wouldn't be cost effective to run another wall in the rink. Mike H. stated it could be stored in the bus garage or warming shed. Mike P. asked what are we doing to support the youth of the community. What happens if it was vandalized or cut? We would likely need to build a storage box when not in use.
- Orin makes a motion for the ripstock liner for \$2,300, Gary second, motion passed.
- In discussion it was assumed maintenance department would be available.
- Orin will follow up with the manufacturer to ask some additional questions.
- Broadbent sign is being worked on Eagle Scout project. Should be completed by spring.
- Port-a-Potty to be moved to four seasons at end of the month from Boettcher.
- Linwood Park sign has been replaced for Givens park after construction.
- Lois Kelzer will be talking about preserving the cemetery prairie tomorrow evening at board meeting.

Four Seasons Park:

Baseball fields were dragged, look nice. The fields do need more limestone added. Pam at the township has a list if teams wish to use the fields on a scheduled basis. The flower garden may include a vegetable garden this year with cooperation from the senior center. Volleyball net will be put up this year.

Martin Lake Shores:

Lakeside park sign is rotted beyond repair to be removed and replaced with a standard Linwood Park sign so those from the lake are aware it is a park. Recommended to maintenance to keep small tree growth removed to not block view of lake.

Playful Shadows:

Leaning tree over walking path is dangerous and needs to be taken down. Playground in good condition, could use a wheelchair accessible mat to access swingset.

Remove edging and cease putting mulch under park sign, let it grow as grass, easier to mow and maintain.

Allquist Park:

Need another bench along ballfield and/or remove existing deteriorated bench. Eventually will need the surround barrier around the playground to be replaced with the plastic border. Should be adequate for another year or two.

Fairway Flyerz Disc Golf:

A starting sign needs to be replaced as it is missing. Low areas which are hard to mow due to roots are to be filled in with mulch to even out ground. Trees need to be trimmed along fairways.

Paradise Point:

Rustic use, leave as-is which allows for canoe or kayak launch. Look to add a picnic table.

Givens Park: Looks good.

Boettcher Park:

Drag parking lot as it has been rutted up with tire tracks. Adjust mount on equipment piece (it is a stand-up piece of equipment which mimics cross country skiing motion). If an archery range was to be installed, this park would be a top consideration. Look to add more rubber "mulch" to playground area and add a wheelchair accessible ramp to access playground.

Olympic Green:

Remove edging and bushes under sign. Asphalt in good shape, will need sealcoating in future, equipment looks good.

Broadbent Park:

In process of obtaining quotes for tennis courts and basketball surfaces. Replace chain nets with rope nets. Spray backboard of rusted basketball hoops. Replace broken bench by basketball court. Remove edging under sign on East side to allow for easier mowing and maintenance. Light pole near basketball court has the plastic conduit broken at bottom, wires exposed, needs to be repaired. Touch-up paint on pavilion. Parking lot poles to be replaced and painted as needed.

It was in consideration to treat a few of the mostly used parks such as Broadbent, Four Seasons, Boettcher (by pavilion and equipment only) for weed control and sandburs.
